Preamble of the North Atlantic Treaty from 1949:

The Parties to this Treaty reaffirm their faith in the purposes and principles of the **Charter of the United Nations** and their desire to live in peace with all peoples and all governments.

They are determined to safeguard the freedom, common heritage and civilisation of their peoples, founded on the principles of democracy, individual liberty and the rule of law.

Guatemala

State Department March 2022:

- Guatemala remains a key transit route for narcotics to the United States and cash returning to South America, creating challenges for the government in combating corruption, money laundering, and financial crimes related to narcotics trafficking.
- Constitutional Court experienced tumultuous changes in 2021 that raise international concern about the state of democratic institutions and the rule of law in Guatemala.
- Guatemala continues to struggle to enforce its AML/CFT and asset forfeiture laws.

US Congress May 2021

 U.S. accuses senior officials and politicians in El Salvador, Guatemala and Honduras of corruption

GFI October 2021:

- There is the sense that AML/CFT requirements are "very strict for normal people," but very flexible for powerful people," according to a former investigator.
- This not only undermines legitimate AML/CFT and anti-corruption efforts, but creates barriers to inclusion for the 91 percent of the population living in poverty.

Welcome To The Club

The United States is the best place to hide and launder ill-gotten gains (Treasury Dec. 2021)

The UK is the global money-laundering capital. Its antimoney laundering measures need a complete reset (Chatham House Dec. 2021)

The EU has a fragmented approach to preventing and coun-tering money laundering and terrorist financing (ECA June 2021)

The FATF Has Turned Into A Burden

- 1. The FATF is failing to deliver on its mission to fight money laundering and the financing of terror;
- 2. FATF's 40 recommendations are used by autocracies to target critics by passing legislation that allegedly are necessary to meet the FATF standards.


